# Lesson 1: Purpose of Marriage and Who You Can Marry

- Who is permitted and prohibited to marry in Islam (mahram and non-mahram)
- Compatibility (kafa'ah) in selecting a spouse

## Lesson 2: Consent, Guardianship, and Conditions for a Valid Nikah

#### **Topics Covered:**

- Proposal, acceptance (Ijab and Qabul) and Witnesses
- The role of a wali (guardian) in marriage
- Can a woman marry without her parents' or wali's consent?
- Location of Nikah—mosque, home, or other settings
- The Khutbah (marriage sermon) and the recommended supplications
- Common errors and cultural practices that conflict with Islamic principles

# Lesson 3: Mahr (Dowry) and Walimah (banquet)

#### **Topics Covered:**

- Definition and purpose of mahr in the Qur'an and Sunnah
- Prompt (mu'ajjal) and deferred (mu'akhkhar) forms of mahr
- What amount is considered appropriate and reasonable?
- Can the mahr be waived by the bride?
- Examples of mahr from the Prophet #
- The Sunnah of Walimah its timing, significance, and simplicity

## Lesson 4: Rights and Responsibilities in Marriage

- Mutual obligations between husband and wife
- The wife's rights
- The husband's rights

# Lesson 5: Rights continued, Intimacy and Boundaries in Islam (Part 1)

### **Topics Covered:**

- Permissible forms of sexual intimacy in marriage
- The importance of mutual consent and emotional safety
- Building comfort, trust, and mutual understanding
- Privacy, modesty, and respecting personal boundaries

# Lesson 6: Intimacy and Boundaries in Islam (Part 2)

#### **Topics Covered:**

- Acts that are impermissible in Islam
- Intimacy during fasting and menstruation
- Addressing discomfort or dysfunction within marriage
- Fulfilling marital desires within ethical guidelines
- Contemporary questions and modest guidance

### Lesson 7: Divorce, Khula, and Annulment

- When is divorce valid, and when should it be avoided?
- The correct method of issuing a divorce
- The issue of issuing three divorces at once—one or three?
- Types of divorce: revocable (raj'i) and irrevocable (bain)
- Which words will constitute a divorce?
- What is Khula? How and when can a woman request it?
- Judicial annulment (faskh) of a nikāh
- What if a husband refuses to issue a divorce?
